BY THIS POWER OF ATTORNEY I/We _____ the undersigned wish to avail various services offered by **Shree Bahubali Stock Broking Ltd** (SEBI registration No.**INZ000103838**) (hereafter referred as **SBSBL**), a company incorporated under Companies Act, 1956 and having its registered office at **12, India Exchange Place, Jute House, 3rd Floor, Kolkata-700001** subject to the following recitals and terms and conditions.

And whereas **I/We** am/are an investor engaged in buying and selling of securities through **SBSBL**, a **Stock Broker** registered under **SEBI**. And Whereas due to exigency and paucity of time, **I/We** am/are desirous of appointing an attorney to operate the aforesaid beneficiary account on my behalf for a limited purpose in the manner hereinafter appearing:

NOW KNOW WE ALL AND THESE PRESENTS WITNESSTH THAT I/WE THE ABOVENAMED DO HEREBY NOMINATE, CONSTITUTE AND APPOINT SBSBL as **my/our** true and lawful attorney (hereafter referred to as the attorney) for me/us and on my/our behalf and in my/our name to do instruct the aforesaid depository participant to debit securities and/or create a pledge / re-pledge (as per SEBI specified mechanism) there out to Pool & Early PayIn /client securities margin pledge account from the aforesaid demat account for the purpose of delivering/pledging/re-pledging the same to the clearing house of the recognized stock exchange toward in any segment to discharge my / our settlement / Margin obligations in respect of securities sold by me /us or for the purpose of providing margins in respect of the trading position taken by me/ us in **NSE(CM-F&O-CDS-SLBM-COMMODITY)/ BSE(CM-F&O-CDS-SLBM-COMMODITY)** segment as well as providing the exposure in the mentioned segments. SBSBL may subsequently re-pledge the pledged securities in favour of Clearing Corporations as per the guidelines specified by the regulator from time to time. In case of shortfall, trading member / clearing member / clearing corporation (as the case may be) shall have the authority to invoke the pledge for recovery of outstanding, if any.

This authority is restricted to the pay-in/Margin obligations arising out of the transactions of purchase/sale effected by me through **SBSBL** and **I/We** ratify the instructions by the aforesaid Clearing Member to the Depository Participant named hereinabove in the manner specified herein. This **POA** is further given with the understanding that **SBSBL** would return to the client (s), the securities that may have been received by it erroneously or those securities that it was not entitled to receive from the client(s).

And **I/we** do hereby further confirm and declare that this power of attorney is and shall be valid to issue instructions relating, executing delivery/receipt instructions, pledge / re-pledge creation instructions, pledge / re-pledge closure instructions, offer for sale, buy back of securities and to operate the depository account which are or may be necessary towards obligations for transactions on any of the Stock Exchange through **SBSBL**. All other transactions including transfer of securities for off market trade in the above mentioned demat Account shall be executed upon instruction by me / us. **My /our** attorney **SBSBL** shall not be liable for any loss that may result from failure/inability in electronic connectivity. Further the said attorney is not liable for not executing my/our debit instructions due to insufficient securities balance before pay-in day with regards to sale obligation and outstanding debit balance in my demat account. In case of shortfall, SBSBL shall have the authority to

I/We undertake to pay such demat charges/fees and such other charges incurred by **SBSBL** under this **POA** and **I/we** further authorize the said attorney to debit my trading or demat in this respect.

I/We hereby authorize **SBSBL** to send consolidated summary of **Client's scrip-wise buy** and sell position taken with average rates to the client by way of **SMS / email** on a daily basis.

I/We confirm that the powers and authorities conferred by this **Power Of Attorney** shall be revocable at any time.

This Power of Attorney shall be subjected to the jurisdiction of the court of Kolkata.
